## *It's been a massive scam against the world*

Professor Risch is a US medic who's published extensively on Covid-19 and the mathematical modelling of pandemics.

Q: What does the scientific evidence suggest we do in future to control pandemics?

HR: *The appropriate response in future is to release the suppression of Ivermectin and Hydroxychloroquine, to take out all the fraudulent government suppression information, like the FDA website against Hydroxychloroquine, and to let doctors prescribe what they think is in the patients' best interests, and it's not for the government to practise medicine.*

*When doctors can do that, these out-patient treatments work very well, for example, Dr. Marble in the MyFreeDoctor home-medicine group has treated now over 275,000 Covid patients, and had six deaths out of that.*

*It's a remarkable record over the whole United States. His whole group of physicians over the US doing telemedicine have treated close to 300,000 patients, and six deaths, using Hydroxychloroquine and Ivermectin.*

*These things work, all of the propaganda that's gone on to suppress them, to pave the way for vaccines and expensive patent medications, have been propaganda that the government has completely supported.*

***It's been a massive scam against the world, against the United States. These drugs work, there's no question scientifically, they are proven to work, and when used in out-patients in the first five days, or so, of the infection, and they should never have been suppressed in the first place.***

Q: When asked if Professor Risch has received criticism for his views from his peers, because they oppose the mainstream media, Professor Risch replied;

HR: *Well, you have the problem, the mainstream standards are controlled by mainstream media, which are controlled by massive financial interests that also have the same financial interests in the vaccines, and expensive*

*medications; and the same is true for medical research across universities, that a very large amount of clinical research in all United States, Canada, and Europe is supported by pharma (pharmaceutical) company grants to those institutions.*

*The allegiances across all of academic medicine are very large. Jason Fong, who's a physician in Toronto, pointed this out in 2017, in a video that's gone viral, about pharma interference in objective medical science, and this permeates the entire field, so one cannot rely on opinion in this, one has to go and look at the scientific studies and decide for oneself.*

*As the philosopher of science, Karl Popper in the 1950's stated that, "Studies about what scientists believe are unrelated to the way nature works." Nature works, the way it works, and you have to go back to the scientific studies and read them, and think about them, not rely on what people tell you they do, because people have interests that are not necessarily the same as those of scientific objectivity.*

*Don't take my word for it, go back and read what I've written, and then look at the original studies.*

Q: Dr Risch was then asked about Covid booster injections, are they effective, and do we need them?

A: Dr. Risch replied,

*Booster shots are effective starting about two weeks after the shots, lasting about a month/two months. After that, then they become ineffective, so the problem with booster shots is you have to give them every six weeks for people to stay protected, and to reduce transmission, **and that's a completely impractical solution, and will damage their immune systems over time.***
